MALTA TOURISM AUTHORITY Summer Work phase 2020

A call for the temporary engagement to work as Beach Supervisors on beaches and bathing areas in Malta, Gozo and Comino.

The Malta Tourism Authority invites applications from any potential candidates who have reached post-secondary level, including MCAST and ITS students or equivalent. Potential candidates studying subjects or with any work experience related to the Authority's portfolio for summer engagement will be preferred.

1. Engagement will be for a period of 3 to 4 months starting in June;
2. Candidates shall be at least 18 years old by 1st June 2020;
3. Candidates interested in working up to 35hrs/40hrs per week will be favourably considered;
4. Beach supervision covers 8/9-hour days and include Sundays and Public Holidays;
5. Remuneration will be at a gross hourly rate of €7.00 applicable Mon-Sunday and PHs;
6. Eligible Candidates will be working as a service provider with MTA; thus self-employment criteria apply and a VAT number is required.
7. Candidates must indicate clearly whether they are willing to work in Malta (exclusively) **or** in Gozo (exclusively).

The main criterion in the selection of candidates shall be based on an interview related to the job in question.

On submission of application, candidates will be authorising the Malta Tourism Authority to forward details to other entities/departments/companies for the purpose of this call.

Xogħol ghas-Sajf 2020

Espressjoni ta' Interess għal Haddiema ghas-Sajf, biex isir xogħol ta' supervizjoni fuq il-bajjiet f'Malta, f'Ghawdex u f'Kemmuna.

L-Awtorità ta' Malta għat-Turiżmu, se tilqa' applikazzjonijiet minghand persuni li jkunu laħqu livell postsekondarju, inkluż studenti mill-MCAST u l-ITS.
